- 21) To give training to sports like food-ball volley ball, Badminton, tennis, cricket Kho-Kho, Kabbaddi and skilled games, Carom, Chess to build minimum stadium or hall for indoor and out-door games, conduct competition and Matches and start conducting classes for training youth in various sports To provide facilities for betterment of unemployed disabled and orphans in rural and urban area by starting small- scale industries.

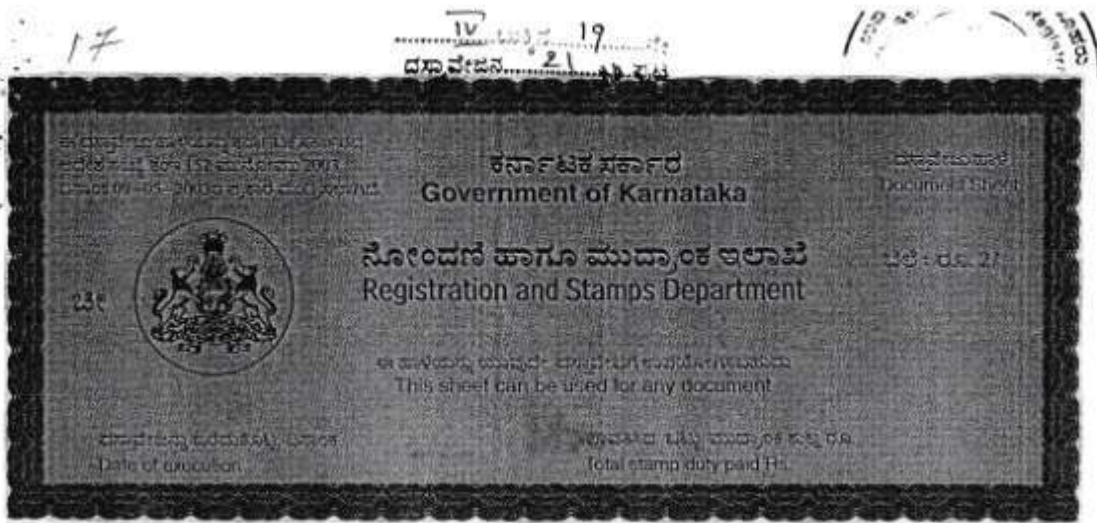

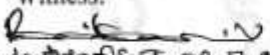

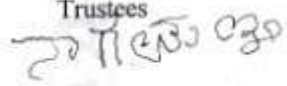
